Motion passed.</li> </ul> <p>Four-year Plan for PY2020 – 2023</p> <ul style="list-style-type: none"> <li>There was much discussion about what members would like to see in the Four-Year Plan. Sector Strategies became the focus and ideas were proposed about how this will be implemented.</li> <li>In setting goals and monitoring progress, Mr. Whitehead proposed Stair-Step system for setting smaller, more short-term goals (Year 1, Year 2, Year 3, Year 4) rather than one large goal to be met in four years.</li> <li>Mr. Whitehead requested that the service provider staff in attendance return to the next meeting with feedback for the tasks related to the current Four-Year Plan, the successes of our El Paso partners, and their view of the Stair-Step system</li> </ul>
